When I receive your deposit I will send you an information packet, which will include a receipt, a map, driving directions, cottage notes and area information. Renters must be 21 years of age.

- 1. RESERVATIONS ARE NOT FINAL UNTIL: The down payment is received in our office. We require that deposits be sent immediately upon verbal or written (e-mail) confirmation of your desire to reserve the specified week(s) or days. The cottage will not be held without a down payment.
- 2. FINAL PAYMENTS must be made two weeks before arrival or we reserve the right to rent the cottage to someone else.
- 3. REFUNDS. Reservation down payments and final payments are non- refundable if you cancel and the cottage remains unoccupied for the week you reserved. We will refund your payment(s) minus a \$25 processing fee if we manage to rent the cottage to someone else for the entire reserved period or we will give you a corresponding partial refund if the reserved period is partially rented.
- 4. CHECK IN AND OUT. Check in is 3 p.m. or after, check out is by 10 a.m., on the days specified on your receipt. Please don't arrive early. Once in a while special check in times can be made by prior arrangement. Call or e-mail.
- 5. The Cottages are NON-SMOKING units.
- 6. MAXIMUM sleeping capacity is 7. Some dates are rented to 1 to 4 persons at advertised price.
- 7. MINIMUM STAYS. In summer the cottages are rented by the week. In early spring and late fall we will rent a minimum of 3 nights. If you choose to stay less than the minimum or reserved time, you will still be charged the full amount. There are no refunds for late arrival or early departure.
- 8. HURRICANE OR STORM POLICY. We do not give refunds for bad weather occurring here, where you live or where you are coming from. If this concerns you we suggest you buy trip insurance, which can be purchased on line.
- 9. LIABILITY. The owners of the Cottages are not responsible for accidents, illness or injuries that occur on the premises.
